Sir,

The Medical Assessment and Rating Board has received online application (Part-1) seeking permission for student intake in under graduate course (BHMS) with intake capacity of 50 seats for the academic year 2022-23.

2. As per provision of NCH Act, 2020 Medical Assessment and Rating Board for Homoeopathy (MA&RBH) has been constituted with the mandate to grant permission for student intake to the existing and new medical institution of Homoeopathy. Accordingly, it is to inform you that Part-1 proforma and all the relevant documents submitted by your college were examined as per the existing regulations.

3. On scrutiny and careful consideration of the documents and further observations of the Board, the following shortfalls were observed to be addressed for granting permission for student intake in UG (BHMS) for the academic year 2022-23:

**A. Teaching Faculty:**

- Previous experience of guest faculties, Dr. Rajendra Sambhaji Desai, Dr. Amruta Anil Hon, Dr. Tushar Narayan Bhagwat and Dr. Rupesh Sadanand Dalvi not provided.
- College has provided list of 09 Part time Consultants of Modern Medicine but their supportive documents not provided.

**B. Miscellaneous:** Form-16 of staff not provided. Biometric attendance data not provided.

4. That Board the applicant has set up the Homoeopathic Medical College and teaching Hospital with the component of staff, infrastructure, equipment and instruments and other facilities where as the College has to take urgent and time bound steps to fulfill the above shortfalls for conducting Under Graduate course in Homoeopathy.

5. After considering the provisions of NCH Act, 2020 and its relevant regulations, permission of the Medical Assessment and Rating Board is granted to Vidya Vaibhav Shikshan Mandal Dapoli Homocopathic Medical College, At. Apti, Po. Talsure, Tal. Dapoli, Dist. Ratnagiri, Maharashtra, Dapoli-415712 with intake capacity of 50 seats for continuing UG (BHMS) course with intake capacity of 50 seats for academic session 2022-23.


6. The Principal is directed to fulfill the deficiencies within 30 days and compliance report shall be submitted in this regard in this regard from the Controlling Authority of the College within a period of 07 days from issue of this letter of permission.

7. All admissions in Under Graduate (BHMS) course shall be through 'National Eligibility Entrance Test (NEET)' only. It is further informed that, minimum 15% seats of permitted intake capacity of BHMS course shall be treated as All India Quota. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board for Homoeopathy as per rules and the penalty as decided by NCH will be imposed.

8. The counseling for seats under All India quota shall be conducted by respective counseling Authority of State/ UT Government as designated by the Central Government and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned Counseling Authority of that State / UT. 100% Under Graduate of the permitted intake capacity shall be treated as all India quota for Deemed University as they are All India in nature. The Counseling of seats under All India Quota shall be conducted by Central Government.

9. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government for All India quota or the student admitted there under. The category wise list of students admitted may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed.






You are requested to comply with the above mentioned deficiencies within 3 months without fail and submit compliance report.

- 2) The admission shall be done only through the Competent Authorities.


