College is required to follow standard guidelines in the functionality as under:

- Case records should be well maintained in respect of case analysis, evaluation and repertorization.
- Case sheets should have complete demographic details and contact details of patients.
- Diagnosis should be written in ICD 11 criteria

Therefore, Medical Assessment and Rating Board for Homoeopathy has decided to issue permission to Vidya Vaibhav Shikshan Mandal Dapoli Homoeopathic Medical College, Maharashtra, for conducting BHMS course for the academic year 2023- 24 with intake capacity of 50 seats.

All admissions shall be made from NEET qualified candidates only. It is further informed that minimum 15% of seats of the permitted intake capacity of BHMS course shall be treated as All India Quota. Counseling for seats under all India quota shall be conducted by respective Counseling Authority of State/ UT govt as designated by Central Government and counseling for the remaining 85 % seats or as the case may be, shall be conducted by the concerned counseling authority of the



Important Note:

- 1) The Continuation / Extension of Affiliation is issued for the Academic Year 2023-2024 subject to the permission of National Commission for Homoeopathy/Central Council of Homoeopathy, New Delhi/Govt. of India/Department of AYUSH, New Delhi and if the permission is declined by the said authorities this Continuation / Extension of Affiliation shall be treated as cancelled. The college is not authorized to admit the students for 1st year of the course until receipt of permission of the National Commission for Homoeopathy, New Delhi/Govt. of India/Department of AYUSH, New Delhi.
- 2) The admission shall be done only through the Competent Authorities.
